MINUTES OF A FULL COUNCIL MEETING OF SMANNELL PARISH COUNCIL HELD ON 14th MAY 2018 AT THE SMANNELL AND ENHAM CHURCH OF ENGLAND PRIMARY SCHOOL HALL, SMANNELL

865. PUBLIC QUESTIONS NOT ON THE AGENDA

Members of the public discussed the issue of speeding in Smannell and Little London villages, with Frenches Farm raising concerns in particular and in attendance. Cllr. Tim Bilborough asked for any ideas from the members of the Parish Council. The idea of speedbumps was raised and it was recorded that they had been dismissed by Hampshire County Council for safety reasons..

Cllr. Tim Bilborough suggested "20 is plenty" signs and the use of white line road markings to create a narrowing effect in the road to naturally slow the flow of traffic. Cllr. Rod Bowker agreed that Hampshire County Council Highways should be contacted to see what the legalities are surrounding signage and road markings. Once this is established the Parish Council are willing to work with HCC in terms of installation and funding. Cllr. Tim Bilborough to action.

Frenches Farm expressed that they were uncomfortable with members of the public counting cars and monitoring speeding through the woods as they were untrained and unofficial. They outlined that they are putting all the measures they can to help support the reduction of speeding in this area. Members of the council thanked them for their cooperation. Cllr. Rod Bowker will write a letter to users of Frenches Farm to outline speeding regulations. Frenches Farm were in agreement with this.

Cllr. Rod Bowker raised the idea of creating a Speedwatch group. Cllr. Tim Bilborough to action, asking residents for interest and contact Hampshire County Council for advice.
